Waiting List Application FAQ

1. Who should apply?

Any individual or household looking for affordable housing in the Bronx.

2. What are the income requirements?

Each applicant must meet income and household size requirements that are predetermined by government agencies and are subject to change. We will share the income requirements for each unit as they become available.

3. Is this application a lottery?

No, this is NOT a lottery. This application is for the waitlist at Woodlawn Senior Living LLC. Applicants are selected on a first come, first-serve basis.

4. Is this application for seniors *only*?

Yes, the Head of Household must be a senior who is 62+ years old.

5. I am not working, can I apply?

Yes.

6. Is there a deadline to apply?

No, there is no deadline to apply.

7. I have Section 8, can I apply?

Yes. However, the units in this building include Section 8 housing, and applicants with eligible Section 8 vouchers or other qualifying rental assistance programs may apply but must show proof of relinquishing the current subsidy. Additional eligibility requirements may apply depending on the unit type and program guidelines.

8. How much will each apartment cost?

Each apartment has its own rental amount and will be shared as a unit becomes available.

9. I currently receive SSI, can I apply?

Yes, see question #8.

10. Do I need to live in the Bronx to apply?

No, anyone can apply.
